Stallholders shall at all times comply with any directions given by the Lions Club organising committee. Failure to do so may jeopardise future bookings.

1. The Lions Club reserves the right to determine whether the Market Day be cancelled due to inclement weather conditions on the day.
2. Vehicles with a load capacity IN EXCESS OF gross weight 2 tonne will NOT be allowed onto the stall site area unless the organising committee gives specific approval. Shoalhaven City Council imposes strict conditions on the use of the reserve and protection of its surface.
3. Access to the site will be available at 6.00 am with set-up to be completed by 8.00am.
4. Stallholders must go to the allocated site and stay within marked boundaries. No stall to be dismantled, or site vacated, before 1.00 pm unless agreed to by the Lions Club markets coordinator.
5. No vehicles are allowed to move on, or off, the site during trading hours (for safety) unless agreed to by the Lions Club market coordinator.
6. Trading will be from 8.00 am to 1.00 pm unless varied by the markets coordinating committee.
7. Stallholders not in position by 8.00am will forfeit their allocated site which may be re-allocated to other applicants.
8. The use of amplifiers or loud speakers is prohibited without approval of the Lions Club markets coordinator.
9. Stallholders must be totally self sufficient – own tables, canopies, seats, etc.
10. It is the stall holders' responsibility to effect their own public risk and product liability insurance.

The Lions Club shall not be held liable for the loss of, or damage to, stallholder's property whilst on the site.
