CONDITIONS FOR STALLHOLDERS

Stallholders shall at all times comply with any directions given by the Lions Club organising committee. Failure to do so may jeopardise future bookings.

1. The Lions Club reserves the right to cancel the Market. Such a decision will only be taken due to inclement weather conditions on the day or because of conditions on the reserve.
2. It is the stallholder's responsibility to have their own public risk and product liability insurance.
3. The Lions Club shall not be held liable for the loss of or damage to stallholder's property whilst on the reserve.
4. **Access** to the site will be available from **6.00 am** with set-up to be completed by **8.00 am**. Stallholders must go to the allocated site and keep their stall and vehicle within marked boundaries.
5. Where a site is not occupied by 8.00 am it may be re-allocated to another applicant.
6. Vehicles with a load capacity **IN EXCESS OF** gross weight 2 tonnes will **NOT** be allowed onto the stall site area unless the markets organising committee gives specific approval. Shoalhaven City Council imposes strict conditions on the use of the reserve and protection of its surface.
7. **Trading will be from 8.00 am to 1.00 pm** unless varied by the markets coordinator.
8. No stall to be dismantled, or site vacated, before 1.00 pm unless agreed to by the markets coordinator.
9. For safety reasons, no vehicles are allowed to move on or off the site during trading hours unless agreed to by the markets coordinator.
10. Stallholders should vacate the reserve by **2.30 pm**.
11. The use of amplifiers or loud speakers is prohibited without approval of the markets coordinator.
12. Stallholders must bring any equipment they need such as tables, canopies, seats, etc.
13. Stallholders who have booked a site for a market but are unable to attend should advise the markets coordinator. (Contact details other side of page.) Failure to advise may result in being placed on the waiting list.
14. If a stallholder is unable to attend two consecutive markets they may be placed on the waiting list.
15. Site fees will be transferred to the next market no more than twice. When a stallholder is unable to attend three consecutive markets, site fees will be forfeited.
